1. MAJOR HEADING

This L^AT_EX file, which should be compatible with any PC, Unix, or Macintosh-based L^AT_EX system, is intended to present a consistent style so that all authors use the same front-page header, two-column format, and headers and footers. It should be possible simply to replace this text with your prepared text.

Note: You may use any word-processing or page-layout program. The AES paper-submission site will convert your file to a PDF file; you can also submit a PDF. If you do submit a PDF, make sure to embed your fonts and graphics but do not use password protection. **Your PDF should have only Type 1 fonts. Please try to keep the size of the final PDF file below 1 MB.** If it is larger try using lower-resolution graphics to reduce the size of the file.

Papers for AES conferences are not edited by the AES editorial staff. Papers will be published in print, on CD-ROM, and on the AES web site exactly as submitted. It is therefore important that authors prepare their manuscripts in accordance with these guidelines.

Major headings (see above) are in capital letters (upper case), Helvetica font, 10 point size, bold style, left justified. All headings are preceded by a blank line. Body text, like this, is Times Roman font, 10 point size, plain style. It should be fully justified to be flush left and flush right.

1.1. Minor Heading

Minor headings use both upper-case and lower-case letters and, like the major headings, Helvetica font, 10 point size, bold style, left justified.

2. CONTENT

To ensure that conference papers are consistent with the goals of the AES, the following guidelines shall be considered by authors.

Technical content shall be accurate. It should cite original work or review previous work giving proper credit.

If the paper describes a product, the content should dwell on the technical aspects of the equipment (circuitry, layout, specifications, functions, and applications).

Company logos shall not be used. Manufacturers name and model names or numbers shall not be used in titles and abstracts, and should be kept to a minimum in the text (generic descriptions should be used).

The trademark symbol TM is not permitted. Trademarked names in titles and abstracts should be replaced by generic descriptions where possible. If trademarked names are retained in titles and abstracts, they will not be acknowledged as such. The first time a trademarked name appears in the body text, it may be footnoted. The footnote will state that it is registered, and the name of the owner.

3. REFERENCES

References should be numbered and listed at the end of the text, and should be cited in the text consecutively by number [shown in square brackets].

4. WRITING STYLE

Good grammar should be used and writing should be easy to understand. Superlatives should be omitted. Words and phrases shall not be abbreviated in titles, abstracts, nor the first time they appear in the text.

Metric units according to the System of International Units (SI) should be used. Following are some frequently used SI units and their symbols, some non-SI units that may be used with SI units (Δ), and some non-SI units that are deprecated (\square).

5. COPYRIGHT

The top portion of the first page of this conference paper is copyrighted by the Audio Engineering Society and may not be reproduced without permission. Copyright to the content of an AES conference paper remains with its author. However, when submitting a paper for presentation at an AES conference, an author agrees that the AES *Journal* will have the first opportunity to consider it for publication. If it is accepted for publication in the *Journal*, authors will be asked to execute a transfer of copyright agreement.

6. LAYOUT GEOMETRY

Since you will be submitting this paper electronically, you don't have to be concerned about using A4 paper or 8.5 by 11 inch paper. With the current margin settings you will be able to print on either size paper for proofing purposes before submitting your paper electronically.

7. FIGURES

Figures, diagrams, and charts must be dark enough to reproduce in black only. If you are using color in a graph or chart to designate meaning, make sure that the meaning is not lost when your paper is printed on a B&W printer. Do this by using redundant text to identify color lines. Minimum line width is 1/2 point. Figures should fit into either one (see Fig. 1) or two columns.

Figures, tables, and illustrations should be placed consecutively in the text, as close as possible to their reference in the text. Figures must be normally oriented on the page and not turned sideways. All drawings and figures must be numbered (Fig. 1 etc.) and captioned.

Figure labels must be legible, at least 7 point size, using Helvetica font for preference. Filled areas should use screens of dots or cross-hatching rather than grey fills.

Photographs and graphic images should be saved as low-resolution (72 dpi) files and embedded in the text following the same guidelines as those outlined above for figures and tables.

8. EQUATIONS

Long equations are more readable when compressed into a single column in a larger text size:

$$X = a + b + c + d + e + f + g + h + i + j + k + l + m + \dots z$$

Equations that cannot be conveniently compressed into a single column can be extended across the entire page. It is best to put such long equations at the top or the bottom of the page so as not to interfere with the rest of the two-column text on the page.

$$x = y \quad (1)$$

9. PDF FILES

Be certain that when creating the PostScript or PDF file from your \LaTeX files that you have the PostScript Type 1 fonts installed in your \TeX system. If you do not and are instead using the bitmapped versions of the \TeX fonts, then your resulting PostScript/PDF file will look very bad when printed or viewed on-line.
